We operate the mobile application Omealo (the “**App**”), as well as any other related products and services that refer or link to these legal terms (the “**Legal Terms**”) (collectively, the “**Services**”).

Omealo helps people make food decisions quickly and confidently. It uses AI to scan digital menus through QR codes or recognizes text from photos with OCR. Users create personalized dietary profiles using preset or custom filters that reflect their preferences, allergies, and restrictions. After a scan, Omealo analyzes every item and sorts the menu into three clear categories:

- Recommended options that align with your preferences
- Caution items that may include ingredients to be aware of
- Not recommended dishes that don't match your needs

Omealo is designed to make dining easier: whether you are managing allergies, specific diets, or simply trying to eat better. As with any AI-powered tool, menu interpretation may occasionally be incomplete or imperfect, but Omealo continues to learn and improve with every scan. Discover menus with confidence. Eat the way you want. With Omealo.
